**MINUTES**

The meeting was called to Order by Supervisor Garfoot, due to Chairman Judd's absence. Supervisor Garfoot asked for nominations for a citizen to act as temporary chair and run the meeting. Ms. Gorman was asked if she'd accept the nomination and she indicated in the affirmative. The motion carried.

Chair Schlimgen called for nominations for Clerk. Marsha Ralston-Edlinger nominated Jamie Baker. Dionne Babler seconded the nomination. Ms. Baker was asked if she'd accept the nomination and she indicated that she would. Chair Schlimgen called three times for other nominations. None were made and motion was made to close the nominations by Dennis Stampe and seconded by Dave Cordray. Motion carried.

Chair Schlimgen called for nominations for Supervisor I. Al Colvin nominated Dave Garfoot. Dave Garfoot interjected to indicate that he was declining the nomination that he had decided to retire at this time. Thanked the community for their support over the years. Chair Schlimgen called for nominations. Alex Elkins nominated Martha Gibson. Dave Cordray seconded the nomination. Ms. Gibson was asked if she'd accept the nomination and she indicated in the affirmative. Chair Schlimgen called three times for other nominations, none were made and motion was made to close nominations by Al Colvin and seconded by Jamie Baker.

Chair Schlimgen called for nominations for Supervisor II. Dwight Truttman nominated Alex Elkins. Earl Garfoot seconded the nomination. Chair Schlimgen called three times for other nominations and none were made. Mr. Elkins was asked if he'd accept the nomination and he indicated that he would. Motion was made and seconded by undeclared individuals. The motion carried,
