1. Call to Order at 8:03pm. Dale Judd, Martha Gibson and Dave Garfoot were on the call.
2. Reading and approval of Board minutes of August 2<sup>nd</sup>, 2021. Tabled until a quorum of attendees available.
3. Treasurer's report and approval of bills.  

Dave presented the August Financial report. Martha moved to approve the minutes. Dale seconded. Motion passed 2-0.

Martha thought that Lehnher Road might be going to gravel and recycled as it is in such poor shape and only serves two households. Dale suggested it be on the list to be looked at during the next road inspection. Martha suggested Mike could do something in the meantime. Clerk to talk to Mike.

The Clerk reported that the County Transportation Department inspection will initially be \$800, and then \$300 annually thereafter. Clerk to talk to engineer to get an estimate of engineering costs.
