





PUBLIC INVOLVEMENT MEETING

RECONSTRUCTION OF

COUNTY ROAD G ROADWAY AND BRIDGES DANE COUNTY

January 24, 2024 6:00 p.m. to 7:00 p.m.

The reconstruction of County Road G between Mt Vernon and County Road A will be discussed at a public involvement meeting scheduled by Dane County, Wisconsin.

The meeting will be held on Wednesday, January 24th, 2024 from 6:00 p.m. to 7:00 p.m. at the Primrose Town Hall located at 8468 County Road A, Verona, WI 53593. The meeting will also have a link available on the Town of Primrose, Town of Springdale, and Dane County websites to attend virtually. Residents and heavy route users are encouraged to attend via whichever format works best for them.

Dane County Highway will be resurfacing and widening County Road G from County Road A to the Mt Vernon Creek bridge. County Road G will be widened from an existing 11' wide lane with a 4' gravel shoulder to an 11' lane with a 3' paved shoulder and a 2' gravel shoulder. The project will also replace the deteriorated bridge, located ½ mile north of County Road A, with a large aluminum box culvert.

The following year, Dane County will replace a bridge on County Road G over Mt Vernon Creek and two additional bridges between Britt Valley Road and Rettenmund Road over west branches of the Sugar River. The approaches will be reconstructed. Work will consist of bridge removal, grading, concrete masonry, crushed aggregate base course, asphalt pavement, guardrail, erosion control items, and landscaping items.

County Highway G will be closed to through traffic during the bridge/culvert work and may be closed during the widening of the highway, but homeowners and emergency services will have access to all properties.

The widening and resurfacing work will occur in 2024 and is estimated to take 3-4 months with the start date to be determined. The bridge replacement near County Road A will also occur in 2024 and is estimated to take 3-4 weeks to complete. The three additional bridge replacements will occur as early as 2025 and are estimated to take 4-5 months to complete.

Message boards will be used to give advance notice of closures. For the safety of construction crews, residents are encouraged to slow down and be alert when using an active construction zone to access their driveways. Identify alternate routes so the closures will be less disruptive. Avoid the active construction zone during the workday if possible.

The purpose of the meeting is to discuss the preliminary plans and schedule for the roadway and bridge construction projects and gather public input. Any comments that may be of interest to the design team are welcome.

The meeting will be organized in an open-house format and interested persons are invited to attend at their convenience. There will be a presentation at the onset to provide an overview of the projects followed by questions. Representatives from Dane County and Ayres will be available to discuss the design details, address comments, and answer questions. Displays showing some of the proposed project work will be available for viewing.

Persons with a concern or knowledge about the floodplain, historic buildings and structures, public lands, and archaeological sites are encouraged to attend this meeting or provide comments to Dane County.
